### Symetra's Accelerated Underwriting Program

Earlier this year, we launched our Accelerated Underwriting Program, which allows clients to be offered a Symetra permanent life insurance policy without completing an exam or submitting an APS. The program is designed to help expedite the underwriting process for you and your clients. To ensure the accelerated underwriting process goes smoothly, please keep in mind the following:

- Both the Part I and Part II applications must be completed. We don't use tele-interviews, so it's important that both forms are completed.
- This program is available for clients ages 18 to 60 who receive a Standard rate class or better. Please see the [program flyer \(PDF\)](#) for more details.
- The Accelerated Underwriting Program is not available for high-net-worth foreign national clients or those applying for the Chronic Illness Plus Rider.
- No other action is required for accelerated underwriting consideration. Simply submit the business as you normally would.

### Year-end business deadlines

Our goal at Symetra is to help you close your year-end sales as efficiently as possible. Please mark your calendars with these important year-end business processing deadlines:

- We recommend that all underwriting requirements be received at Symetra by **Monday, Dec. 7.**

- To ensure timely processing, final issue requirements for life new business should be received by **Friday, Dec. 18**, for both daily and weekly commission schedules.
- Symetra will continue to process and place business through **Thursday, Dec. 31**.
